

## View Contest Rules

No purchase necessary to enter or win. The Depco Pump Yeti 45 Cooler Contest (the “Contest”) is sponsored by Depco Pump Company, 2145 Calumet St., Clearwater, FL 33765.

1. **ELIGIBILITY:** Only open to current and former customers of Depco Pump Company within the continental United States or Canada, Hawaii, Alaska and Puerto Rico, who are 18 years of age or older at time of entry, and who sign up for Depco Pump Company’s email list. Any entries not eligible for any reason will be disqualified from winning the prize. Employees of Depco Pump Company and their immediate family members (parent, child, spouse, sibling and their respective spouse, regardless of where they reside) and/or any entrant living in the same household of each, whether related or not, are not eligible to participate in or win the Contest.
